### 2022 club charity

We only had one charity nomination this year.

This year's Club Charity will be Magpas Air Ambulance, as nominated by Karen Roper.

Magpas Air Ambulance provide the very best pre-hospital emergency care, in the air or on land, including treatments usually only available in a hospital. Their service operates 24/7 and, on average, answers four calls for help a day treating around 900 patients in lifethreatening emergencies every year.

Magpas serve the communities of Cambridgeshire, Bedfordshire and across the East of England and are dispatched by both the East of England and the East Midlands Ambulance Service Trusts – caring for a population of over 10 million. The oldest emergency medical charity of its kind, since 1971 they have treated over 60,000 patients.

Magpas Air Ambulance is not a state-funded service and relies on generous public donations to continue saving lives.
